## 2019 Person In Charge Food Training



Lincoln Trail District Health Department conducts monthly training on the Person in Charge requirements listed in the 2005 FDA Food Code. There is a \$50.00 fee to take the exam and students must be able to pass a written exam. Certification is valid for 3 years. Seating is limited to the first 50 participants registered.
